## Regular Meeting Minutes May 1, 2012

Present: Chairman Groselle, Steve Pancost, Kathy Schulda

Chairman Groselle opened the meeting with the Pledge of Allegiance and the reading of the April 24, 2012 minutes. Steve Pancost motioned to approve the minutes. Kathy Schulda seconded the motion. Roll Call Vote: Groselle AYE, Pancost AYE, Schulda AYE.

A hearing for the condemnation of 12955 Thrasher/Rapids Rd. was not convened by the Hiram Township Trustees. No one was present but instructions were given to the Fiscal Officer to contact the remaining Lien holders by regular mail to come forward by the June 19<sup>th</sup> meeting. If no one comes forward, the condemnation will proceed and all expenses will be added to the taxes.

## Fiscal Officer Report:

A vote is needed to pay the legal fees pertaining to the annexation. Kathy moved to pay the invoices from Scot A. Stevenson, LLC. Steve seconded the motion. Roll Call Vote: Groselle Abstained, Schulda AYE, Pancost AYE. The Motion was passed and the invoices will be paid.

We have received a written notice that the annexation has been approved by the County Commissioners.

Fire Report: Kay Ziska, Hiram Village Fiscal Officer, sent us a quarterly fire protection and emergency services report for the first quarter of 2012. It showed receipts for township EMS runs were \$6,373.46

Zoning Report: Mr. Koscher was present and said he will continue to work on the problem. Rich will check every two weeks to review any progress.

Tom Bosma was also present and is concerned with some solid waste on Allyn Road. Rich will go investigate.

Demolition at 7645 St. Rt. 82 will be starting within the next month. No township permits are required.

No progress yet at 6058 St. Rt. 82 with the animals in the front yard. Rich will continue to follow up.

Old Business: Steve Pancost has met with people from Hiram College and Hiram Village. They hope to have some deal in place by June concerning the 2 percent village income tax and other issues between the three parties.

Steve also attended the Parks and Rec Fund Raiser and had a very nice time.

Kathy reported that the Port-O-Potty is in place at the ball field for a six month lease. And we have received a certificate of Liability Insurance from Ohio Hot Stove Baseball to cover the baseball field. The contact person for the team is Valerie Conley at 330-274-8651 or 330-842-0228.

The job classification description of part-time township road crew is OK to use.

Kathy moved to pass a resolution to bill all expenses incurred doing the condemnation of the properties on Thrasher/ Rapids Rd. Be added to the taxes. Steve seconded the motion. Roll Call Vote: Groselle AYE, Schulda AYE, Pancost Aye. The motion was approved and a resolution will be drawn up and presented at the next meeting.

Jack has received word from Scott Kenreich, District Conservationist for Portage & Summit Counties, USDA- Natural Resources Conservation Service. Progress is being made on authorization to deal with the beavers and final approval should be coming soon from Columbus.

New Business: Steve asked Tom Matota to go look at some drainage issues on Aylln Road. Tom said he would.

Kathy asked about any liens we would have on the property at 11588 Vaught Rd. Chicago Title was asking and no one could think of anything we would have.

The sheriff's Office is having an Open House on May 20<sup>th</sup> from 1 till 4 pm.

Road Report: John Ziska will be forwarding a copy of the agreement concerning the sharing of work and repair of Hankee Rd. Tom will review it and bring it to the next meeting.

Tom commented that berm work is going well.

Steve Pancost motioned to pay the bills. Kathy Schulda seconded the motion. Groselle Abstained, Schulda AYE, Pancost AYE. The motion passed and the following bills were paid.
