Regular Meeting Minutes November 7, 2012 7:00 PM

The quarterly Health Department's report was received. They had done 91 inspections in the township over the last quarter.

Josh Johnson talked about the web site that he is proposing to the township. Resolution 2012-18, to have Josh Johnson do the Hiram Township Website starting January 1, 2013, was discussed and approved by the Board of Trustees.

Hiram Fire Department Report: The Halloween Party went well. All is good at the Fire House.

Old Business: Steve said that the Forestry Plan does have some grant money for communities with property.

Kathy now has a case number with the State Tax Committee to plead her case concerning the Village income tax issue. And Hiram Village still does not have a Tax Board.

Jack reported that the Solid Waste Committee has added all the changes wanted by our Township and now needs approval by 76 per cent of the membership. A public comment meeting will be held December 5th.

It will be going to the Board of Zoning Appeals. A mylar has been signed for Webb's property on pioneer Trail. And he has a meeting with Seneffs on November 8th.

Road Report: Tom reported that no crack filling was done due to the weather. All equipment is ready for winter. He would like to replace one of the plow trucks next year at a cost of about \$125,000.00. Stan will look at the books to see if we can butyit of finance it.
