**Resolution 2020-44:** Jack Groselle motioned to advertise for construction bids per the specifications defined by Hal Stamm. There has been no progress on the Verizon account. As the administrator, Diane will follow up on the account to authorize Jack Groselle to discuss the account and be able to exchange information by email.

Jack Groselle requested Diane to write a letter to Hiram College about the Hiram Field Station driveway. The gravel washing into the roadway is a safety hazard.

#### **New Business:**

Steve Pancost researched the Family First COVID 19 Policy. Steve will bring more information and a sample Memorandum of Understanding for government entities to assist each other. Per the Ohio Revised Code, the township can receive up to 8 hours of assistance. Steve will continue to research as information becomes available. Jack Groselle asked for employees to be tested if they become ill.

Jack Groselle received a notice from the Portage County Health Department regarding Glen Shoemaker, Winchell Rd who is being prosecuted for disposing of tires on his property.

Steve Pancost reported that Portage County Regional Planning is looking into a grant for improved broadband in Windham, Nelson, and Hiram Townships.

#### Zoning:

The Portage County Assistant Prosecutor, Brent Bencze has sent a letter to Mr. Summers. A material shortage has prevented Mr. Summers from completing the work.

Rich Gano was notified of a new construction building on Mumford Road. Rich has not received a permit for this property and he will be looking into it.

Steve Pancost reported that the camper on Udall Road was moved.

Rich Gano signed the Prosecutor's Complaint regarding non-agricultural property belonging to Mr. Yoder on State Route 305. The newly constructed barn met the 1200 sq ft limit prior to adding the addition on the east side.

The concerns regarding the Byler property on Wheeler will be directed to the property owner rather than Levi Byler.

Rich received an inquiry about developing 80 acres on State Route 700 into a sub-division. It will be addressed by Regional Planning.

# **Road Report:**

Tom Matota recommended that 2020 chip and seal be postponed to 2021 due to the amount of liquid that is rising up through the stone. The original plans were for Udall, Norton, Winchell, and Wheeler Roads. Jack Groselle suggested that Tom follow through with one half of the original plan in 2020.

Tom also suggested that Rolling Meadows should be reground and paved. It will need a 2" leveling course and one layer of chip and seal at a later date. The paving could be bid out next year. Tom thinks the garbage trucks are adding a lot of wear and tear on the roads.
