Diane Rodhe presented the following items:

OTARMA sent a notice to remind elected or re-elected officials to file the paperwork for the Faithful

The Portage County Board of Elections sent the notice for the upcoming November election.

The NOPEC Community Event Sponsorship grant program sent a check for \$1000.00 to the Middlefield Bank on behalf of the recipient, Hiram Fire Association. A check has been issued in the same amount to

the Hiram Fire Association.

Quarterly financial reports were provided to the Trustees.

**Police Report:** Vaughn Road has received extra patrol to reduce speeding. No citations have been

issued.

**Fire Report:** September response time is 4 minutes and 34 seconds.

Chief Byers reported the DTNPM inspection for the trucks as complete and the department received a

card of thanks from an Asbury Road resident.

The Fire Department is discussing a drive-thru event for Halloween due to COVID restrictions.

## **Old Business:**

**Resolution 2021-70:** Steve Pancost motioned to approve the payments to Russell Standard for RS2 Liquid based on Resolution 2021-55. Debra Blake seconded the motion. Roll call vote was taken. Steve AYE, Debra AYE.

Refer to "Resolution 2021-55: Jack Groselle motioned to purchase CRS-2 Liquid at \$1.88 or \$1.97 delivered. Debra Blake seconded the motion. Roll call vote was taken. Jack AYE, Debra AYE, Steve AYE."

The Portage County Water Department sent the official notice of denial for supplying water to the building at 6352 State Route 82.

The Good Deeds presentation has not been scheduled.

The Village of Hiram decided to move the date for Halloween Trick or Treat to October 30 from 4 to 6 PM. The township will be the same evening.

**Resolution 2021-71:** Debra Blake motioned to increase police patrol on township roads from 60 hours per month to 100 hours. Steve Pancost seconded the motion. Roll call vote was taken. Steve AYE, Debra AYE.

Hiram Village and Hiram Township have published a bid notice for recycle and trash service to begin on December 16, 2021. The bids are due before October 29, 2021 and will be opened at the Village Council meeting.

The American Rescue Plan has deposited \$125,000.00 into the Middlefield Bank account. Steve Pancost has talked with Christine Craycroft to inquire about getting an engineer to help the township decide how the best use the funds.

## **New Business:**

Chief Byers has requested a safety evaluation for the areas where State Route 700, State Route 82, and Pioneer Trail intersect. The Portage County Engineers' Office will create a report.

## Zoning:

Rich Gano reported that he has collected fees for one variance, one impact fee, and five building permits.

## **Road Report:**

Tom Matota met with a Portage County Engineer to discuss the ODOT Stimulus Program. Several potential projects were evaluated and the engineer suggested the Vaughn Road culvert project as having the most potential to be awarded funds from the grant. A counter has been placed on the road as part of the evaluation.

Chip and seal is complete for 9.8 miles of township roads.

The 2016 dump truck will be going in for repair and preventative maintenance. The estimate for repairs is \$1400.00. The 2014 dump truck will be going for preventative maintenance as well.

Debra Blake motioned to go into Executive Session to discuss personnel at 7:56 PM. Steve Pancost seconded the motion. Roll call vote was taken. Steve AYE, Debra AYE.

Debra Blake motioned to come out of Executive Session at 8:17 PM. Steve Pancost seconded the motion. Roll call vote was taken. Steve AYE, Debra AYE.
