Regular Meeting Minutes

January 25, 2022 at 7:00 PM, Hiram Township Complex

Present: Trustees; Chairman Jack Groselle, Steve Pancost, and Fiscal Officer Eric Hankinson.

Reading of the Minutes:

Mr. Pancost motioned to approve the December 22, 2021 and January 02, 2022 Meeting Minutes.

Mr. Groselle seconded the motion. Roll call vote was taken. Jack AYE, Steve AYE.

Public Comment:

Frank & Sylvia Tench spoke up about issues they are having with Google Maps misrepresenting their home as a street. They have repeatedly contacted Google and have yet to receive a resolution. They asked the Board for help in getting someone from Google to remove their address and correct the mistake. Mr. Pancost took point to find someone that can provide some help on resolving their issue. They also commented very favorably how well Tom Matota and the Township Road Crew maintain their street (Cadek).

Fiscal Officer:

Mr. Hankinson received approval from the Trustees to send Integra their last checks for 2021.

Positions of the Board were appointed. Mr. Pancost motioned for Mr. Groselle to remain Chair of the Board. Mr. Groselle seconded. Roll call vote was taken. Jack AYE, Steve AYE. Mr. Groselle then motioned for Mr. Pancost to be the Vice-Chair. Mr. Pancost seconded the motion. Roll call vote was taken. Jack AYE, Steve AYE. Next, Mr. Groselle motioned that the Board continue to hold meetings on the third Tuesday of every month, that the meetings are at 7:00pm, and that they are held at the new building located at 6352 Wakefield Rd. in the Township. Mr. Pancost seconded the motion. Roll call vote was taken. Jack AYE, Steve AYE.

Member appointment for Regional Planning 2022 was chosen. Mr. Pancost would remain the main contact with Mr. Groselle remaining the secondary contact. Mr. Hankinson noted that W2s and 1099s would be sent out in the coming days to everyone. He also noted that the Occupancy Permit for the new building was received. The Bank Reconciliation for December 2021 was not finished due to still issuing

payments against 2021 funds. Mr. Hankinson is still working with Middlefield Bank to get the necessary access to the various accounts. Mr. Hankinson also noted that he would be updating the medical coverages to remove the late Ms. Rodhe from them.

New Business:
